

Business Licenses

Do I need a business license?

Generally, all businesses operating in or soliciting business in the corporate city limits of Tacoma are required to be registered and licensed with Tacoma. You need to register with the City if you are located within the City's limits, solicit, or conduct business in Tacoma, whether directly or through a representative, or do business with the City of Tacoma through contracts. If you are unsure whether or not your business is required to register, contact the [Tax and License Department](#) at 253-591-5252.

Corporations, LLC or LLP

If your business is a corporation, limited liability company, or limited liability partnership, you must first contact the Corporations Division of the Secretary of State at 360-725-0377.

General Contractors

All sub-contractors working at a job site in Tacoma must also be licensed with the City of Tacoma. If any of your sub-contractors do not have a City of Tacoma business license have then contact Tax & License Division at 253-591-5252 or download the Application for Certificate of Registration and Licensing. Post this [printable flyer](#) to post at your job site.

How to Apply

There are three ways to apply for registration and business license:

By Mail - To apply by mail download the [Application for Registration and Business License](#) form, complete the form and mail it to the address listed. Please allow 10 to 15 business days to process.

In person - To apply in person, visit our office at 733 Market St Room 21, Tacoma WA 98402. You can complete the applications, pay the license fee and in most cases receive your business license the same

day. Please allow 45 to 60 minutes to process a new business license application. Applications received after 4 PM will be accepted however may not be processed the same day.

Online - New businesses can now apply for their City of Tacoma business license online using [FileLocal](#), your one stop for local business licensing and tax filing. Online user fees apply. Please allow 3-5 business days to process your application.

Home Occupations and Agreement

If your business address is based from your home and you live inside the City of Tacoma limits, a Home Occupation license is required. Please complete and return the [Home Occupation Agreement](#).

Regulatory Licenses

In addition to a business license, some business activities require a regulatory license not listed here. You can also view a full listing of [regulatory licenses](#).
