

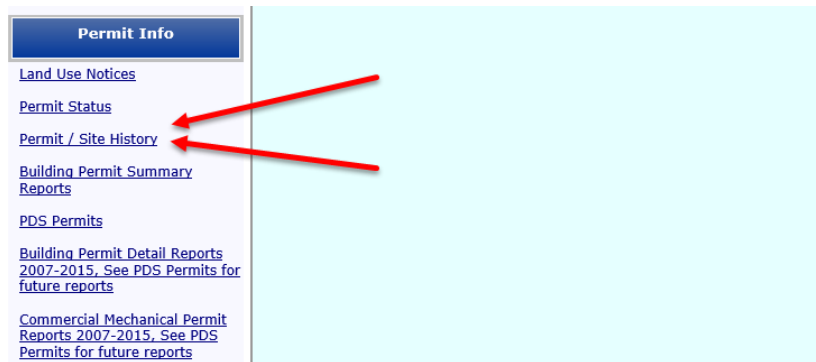
View and Print Side Sewer Inspection Cards

The City of Tacoma has permit records for some, but not all, of the side sewer inspections in the City of Tacoma. For recent permit history call Site Development at 253-591-5760 or email at sitedevelopment@cityoftacoma.org. You may also search the City's online records for permit information and verify that a permit was pulled through our Online Permitting system, at www.tacomapermits.org. The City has more information about homes built after 1950, and has records only of work done with permits. The following steps will guide you through viewing and printing side sewer inspection cards, if any exist for a property. If you have difficulties following the steps below or are unable to find inspection cards, contact Site Development at 253-591-5760 for further help.

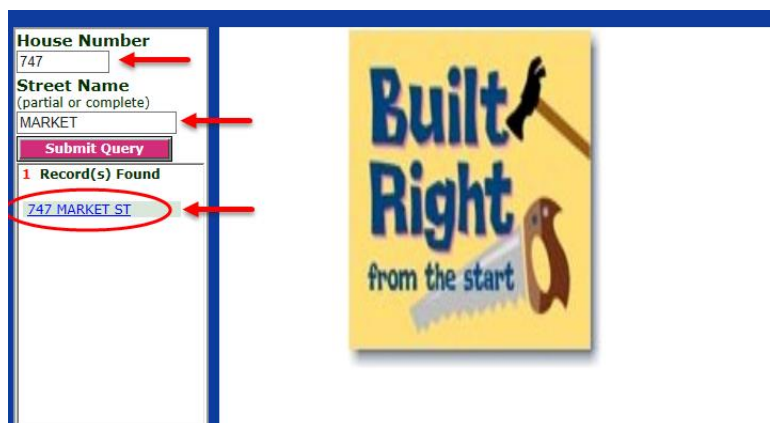
PERMIT HISTORY SEARCH

STEP 1 – Visit www.govME.org

STEP 2 – Scroll Down to **Permit Information** and click on **Permit / Site History**



STEP 3 – Enter House Number and Street Name. Click on **Submit Query**. Click on the link under Record Found. If the query results in "0 Record(s) Found", try to use a partial street name or verify that the address you are searching is valid.

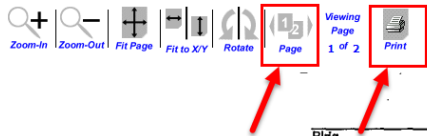

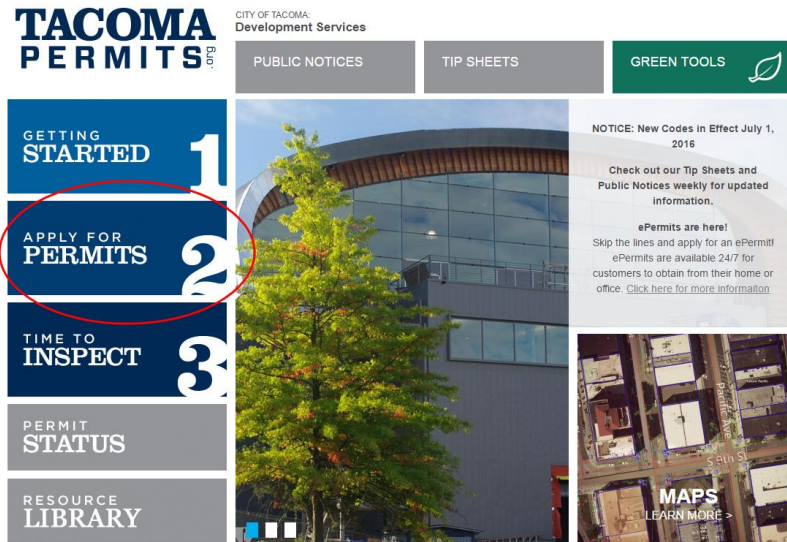

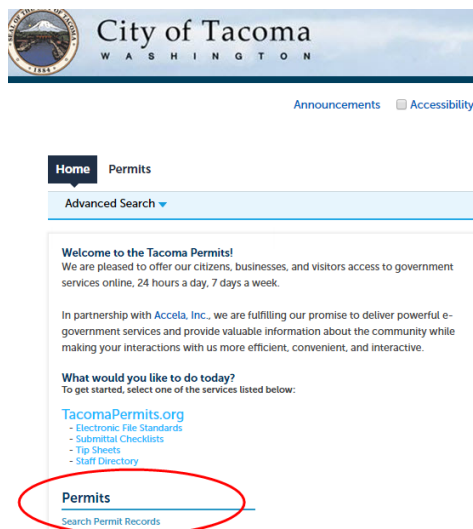
ONLINE PERMITTING SYSTEM

STEP 1 – Visit www.tacomapermits.org

STEP 2 – Click on **Apply for Permits** (this will take you to the Tacoma Permits Online Permitting website or Accela Citizen Access – ACA)



STEP 3 – At the bottom right hand side under **Permits** click on **Search Permit Records**.
